## **2017 A-Team Events: Mark Your Calendars**

### **Congressional District Work Days**

Congressional recesses, or “District Work Days,” are dedicated dates throughout the year for members of Congress to spend more time at home with their constituents. When members of Congress return to their home states/districts, their days are usually filled with meetings with constituents, visits to local businesses, town halls and campaign events. District Work periods provide SHRM A-Team members with the perfect opportunity to engage with their federal elected officials locally, and discuss timely workplace issues with the lawmaker and district staff team. [A-Team members: using the highlighted dates on this calendar, start planning your district engagement with your lawmaker now!](#) Congressional calendars fill up quickly, so plan to start the scheduling process sooner rather than later.

### **A-Team Quarterly Planning Webinars**

To help support the ongoing efforts of the A-Team, SHRM’s Government Affairs staff hosts quarterly webcasts to provide the most up-to-date legislative and regulatory information on pending workplace issues, accompanied by strategic advocacy techniques A-Team members can use to effectively engage with lawmakers throughout the year. ### **SHRM Advocacy Events in Washington, D.C.**
