Dear Chairwoman Foxx and Ranking Member Scott:

As you know, the Public Service Loan Forgiveness (PSLF) program provides debt forgiveness to qualifying applicants who have completed 120 on-time, qualifying payments during full-time public service employment. This debt relief enables students to pursue careers that are integral to the health and well-being of our communities, including teachers, nurses, firefighters, police, and so many other public servants across the country. Without PSLF, the combination of student debt and low wages could create a barrier to entry into these professions; therefore, the PSLF program is critical to workforce retention in these fields.


Enacted in 2007 under President George W. Bush to inspire more graduates to enter public service, the PSLF program is now seeing its first applicants granted debt forgiveness. Yet, little is publicly known about this process or program participation rates. Thus far, only twelve individuals are considered on track to earn forgiveness in the near future, so Congress has plenty of time to evaluate the program at virtually no cost.

It is our understanding that H.R. 4508, the PROSPER Act, would end this important program in 2019 for borrowers entering new courses of study and for all borrowers in 2024. As members of the bipartisan Public Service Loan Forgiveness Caucus in the House of Representatives, we urge the Committee to refrain from restricting access to the program until more is known about its participation rates, benefits to employers and participants, and impact on the federal budget.






