The proposed FOCUS grants would provide supplemental awards to school districts that agree to adopt weighted student funding combined with open enrollment systems that allow Federal, State, and local funds to follow students to the public school of their choice.

/b Includes \$8.2 million for competitive assessment grants.

/c In 2017, Congress included language in the final appropriations bill allowing grants to be distributed within a state on a competitive basis at the state's discretion.

/d Includes \$250 million for competitive awards for applicants to provide vouchers in the form of scholarships for students from low-income families to attend the private school of their choice and to build the evidence base around private school choice.

/e Includes \$20 million to support a competition to promote the development, enhancement, implementation, or expansion of innovative CTE programs in STEM fields.

/f Reflects discretionary funding only. Mandatory funding is excluded.
